The specific purpose of this corporation is to form a community based organization with a goal to assist those seeking recovery.

Thanks to the generous donations of community members and other supporters of Daryll's House, Inc, we have met our first goal. We opened Daryll's House, a meeting hall, in Indio, CA and are already holding meetings and other events on a regular basis.

Our Vision is to continue raising funds to purchase a building that will house these meetings. Then, when funds allow, to open a clean living house – possibly at the same location – to continue to help those that are trying to help themselves.

## Membership information.

**Qualification of Members:** Any person, regardless of age, sex, creed, race or religion who is interested in rehabilitation and education of persons in need thereof due to alcoholism and drug related dependence problems is eligible for membership.

**Disqualification of Members:** Any member who repeatedly violates the membership guidelines established by these Bylaws or the House Rules may be removed from membership after notice from and hearing before the Board of Directors, by action of the Board at any regular or special meeting.

**Member Rights and Privileges:** All members shall have the right to vote at all membership meetings, and to attend any meeting of the Board of Directors and express their opinions and views. A member may serve on any of the committees authorized under these Bylaws or authorized by the Board of Directors, provided he or she has been selected to do so by the Chairman of the committee.

### Membership Meetings

**Annual Meeting:** The annual meeting of the Club membership shall be held at the Club premises on the 3rd Monday of April or on such other date as designated by the Board of Directors. The purposes of the annual membership meeting shall be to review Board activity for the prior year and hear reports of officers and committees; to elect members of the Board of Directors; and to transact any other business that may be properly brought before the meeting.

**Special Meetings:** A special meeting of the membership may be called by the Board of Directors or upon the petition of 20% or more of the members.

**Notice of Meeting:** Notice of the annual membership meeting shall be given by posting notice thereof on the Clubhouse bulletin board at least 30 days prior to such meeting, or in such other manner as prescribed by the Board of Directors. Notice of special meetings shall be given as prescribed by the President or, in his absence, any Vice President.

**Voting Rights:** Each member shall have one vote at all membership meetings, in person or by written proxy. A quorum shall consist of at least 50% of the members.
